Privacy

The personal data processed by W.H.V. Centauri is restricted to only those data that are necessary for the purposes for which they are processed.

Which personal data is involved?

Current members

The information you have entered on your registration form and authorization form, but also data such as tournament and match results, IBAN and (group) photos during activities and sport events.

Former members

First name, last name, e-mail address, period of membership and reason for unsubscribing.

Donators

First name, last name, e-mail address and IBAN.

Visitors of the website

No personal data is stored from visitors on the website.

What are the personal data processed for?

Current members

- General provision of information (invitations and newsletters via e-mail, information via WhatsApp, information via Facebook);
- Being able to provide training (data goes to SCB De Bongerd and SWU Thymos);
- Member administration and thus analysis of member composition and numbers;
- Contribution levy via direct debit (data goes to ING);
- Promoting the association and providing information to external parties (for example, carefully selected photographs are used on the site and/or Facebook, see also the heading 'Social media and website').

Former members

- General provision of information (newsletters via e-mail and invitations to Lustrum and other meetings);
- Member administration.

Donators

- General provision of information (invitations and newsletters via e-mail);
- Member administration;
- Payment control donation.

Visitors of the website

Does not apply.

Social media and website

W.H.V. Centauri provides members and other interested parties through social media and the website with information about activities within the association. The image and text material used for this is carefully selected. Should undesirable image and/or text material be placed online by W.H.V. Centauri despite this careful selection, then it is obviously possible to object to this and the material will thereafter be removed or modified (see 'Your rights concerning your data').

Safety

Data stored at W.H.V. Centauri are kept safe and are only accessible to the board. Committees may inspect parts of personal data if this is deemed relevant by the board.
