Special and/or Sensitive Personal Data We Process

W.H.V. Centauri processes the following special and/or sensitive personal data from you: Our website and/or service does not intend to collect data about website visitors who are under 16 years of age unless they have permission from parents or guardians. However, we cannot verify whether a visitor is over 16. Therefore, we recommend that parents be involved in their children's online activities to prevent data about children from being collected without parental consent. Centauri remains responsible for these processing activities. W.H.V. Centauri shares the following data with the membership administration of Sports Centre de Bongerd:

Cookies We Use

W.H.V. Centauri does not use cookies or similar technologies.

Accessing, Correcting, or Deleting Data

You have the right to access, correct, or delete your personal data. You also have the right to withdraw your consent for data processing or object to the processing of your personal data by W.H.V. To ensure that the request for access is made by you, we ask you to include a copy of your identity document with the request. In this copy, please black out your photo, MRZ (machine-readable zone, the strip with numbers at the bottom of the passport), passport number, and Citizen Service Number (BSN) for privacy protection. We will respond as soon as possible, but within four weeks, to your request.

W.H.V. Centauri also wants to inform you that you have the possibility to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
